CONNECTION BETWEEN OUR RICH CULTURAL HERITAGE AND THE IMPORTANCE OF PLANTS
TO THE SURVIVAL OF INDIGENOUS PEOPLES AND THE HISTORIC HISPANIC POPULATIONS
OF NORTHERN NEW MEXICO. A SIGNIFICANT PORTION OF THE SFBG CONSISTS OF A
MATURE PIÑON JUNIPER WOODLAND FOR WHICH THE GARDEN'S STAFF IS DEVELOPING A
LONG-TERM MANAGEMENT PLAN. THE SFBG'S LIVING COLLECTIONS ATTRACT NEARLY
23,000 VISITORS IN 2022.
